This is a Pre-Qualification Form. Your child has been recommended as a possible candidate to participate in the 2018 Over-Age-for-Grade Program for 5-7 grade students.

- Program:** Middle School Over-Age-for-Grade
- Eligibility:** Must currently be a District Managed SCS 5th – 7th grade student and one (1) year or more over age for grade (by failing a prior year), and passing current grade. Students are not eligible due to their birthdate and the Kindergarten entrance requirement. Counselor must verify the student has qualified. These students will be eligible for the 6th - 8th grade Over Age for Grade Program.

- Program Hours:** 7:30 AM – 1:30 PM
- Sites:** Craigmont MS, Hamilton MS, Havenview MS, Hickory Ridge MS, Kate Bond MS
- Courses Offered:** 6-8 Language Arts and Math
- Cost:** Free
- Requirements:** Students are required to follow the Summer School policies regarding attendance, code of conduct, and dress code. Parents must agree to these requirements for students to participate in the program.
